The Company has sent the postal ballot notice on 23rd April, 2026 only through electronic mode to those shareholders whose names appear on the Register of Members/List of Beneficial Owners as on Friday, 17th April, 2026 ("Cut-off Date"). Voting rights of the shareholders shall be in proportion of their shareholding to the paid-up equity share capital of the company as on the cut-off date. A person who is not a Member on the Cut-off Date should treat this Notice for information purposes only. Communication of assent or dissent of the shareholders would take place only through a remote e-voting system. Only those shareholders whose names are recorded in the Register of Members of the Company or in the Register of Beneficial Owners maintained by the Depositories as on the Cut-off date, will be entitled to cast their votes by remote e-voting. Members whose e-mail addresses are not registered are requested to follow the process provided in the Notes to this Postal Ballot Notice for registration of their e-mail addresses and for obtaining login credentials for remote e-voting. Once the vote on the resolution is cast by the shareholder, he/she shall not be allowed to change it subsequently.

2. In line with the MCA Circulars, the Notice is being sent only by electronic mode, and a hard copy of the Notice, Postal Ballot Form, and pre-paid Business Envelope have not been sent to the shareholders for this postal ballot.

3. The Company has engaged the services of National Securities Depository Limited (NSDL) for providing the remote e-Voting facility to its Members of the Company.

4. The detailed procedure/instructions on the process of remote e-voting including how the shareholders who have not yet registered their email addresses, can register their email addresses and can cast their vote, are specified in the Notes Section of the Postal ballot Notice.
