मुंबई-नाशिक महामार्गावर आठ किलोमीटर वाहतूक कोंडी; मुसळधार पावसाने जनजीवन विस्कळीत

मुंबई, ठाणे, भिवंडी आणि वसई-विरारमध्ये पाणी साचले ; पुढील पाच दिवस मुसळधार पावसाचा इशारा

राज्याा सुरू असलेल्या मुसळधार पावसामुळे मुंबई महानगर प्रदेशातील जनजीवन बुधवारी मोठ्या प्रमाणात विस्कळीत झाले. मुंबई, ठाणे, भिवंडी आणि वसई-विरारसह अनेक भागांत पाणी साचणे, वाहतूक कोंडी आणि अपघातांच्या घटना घडल्या. भिवंडी परिसरातील मुंबई-नाशिक महामार्गावर सुमारे सात ते आठ किलोमीटरपर्यंत वाहनांच्या रांगा लागल्याने हजारो वाहने तासनतास अडकून पडली. दरम्यान, भारतीय हवामान विभागाने मुंबई, ठाणे, पालघर, रायगड, रत्नागिरी आणि सिंधुदुर्ग जिल्ह्यांसाठी पुढील पाच दिवस मुसळधार ते अतिमुसळधार पावसाचा इशारा दिला आहे.

भिवंडी तालुक्यात दिवसभर सुरू असलेल्या पावसाचा सर्वाधिक परिणाम मुंबई-नाशिक महामार्गावर दिसून आला. अपूर्ण रस्ते कामे, मोठे खडे आणि रस्त्यावर साचलेल्या पाण्यामुळे
