3. During the quarter ended June 30, 2022, the Company had acquired 100% equity shares of PRS Permacel Private Limited (PRS) for a consideration of Rs. 12.112 Lakhs. Subsequently, pursuant to a Scheme of Amalgamation of PRS with the Company, duly approved by the National Company Law Tribunal (NCLT), vide its order dated June 22, 2023, all the assets and liabilities of PRS at fair value were transferred to and vested in the Company with effect from May 27, 2022, being the appointed date. The excess of consideration paid over and above the fair value of the assets and liabilities taken over amounting to Rs. 4,630 lakhs have been accounted as Goodwill. The Company is in the process of meeting the regulatory requirements as prescribed under the NCLT order. Accordingly, the results of PRS for the current quarter as well as the corresponding previous periods have been considered as part of the merged entity itself and not as a part of consolidation.

4. Previous period figures have been re-grouped / re-classified wherever necessary, if material to conform to current period's classification.
